## **PRIVACY NOTICE – COLWYN BAY CRICKET CLUB**

Under new laws effective from 25th May 2018, we are required to provide you with certain details concerning how your personal data will be used and protected.

<b>Purposes of processing</b>	<b>The CBCC will process your personal data for the purposes of:</b>  Administering support to Captains and Coaches to deliver cricket games during the season Identification purposes To enable the communication necessary for running CBCC To send you information electronically and by post.
<b>Who we will disclose your personal data to</b>	L & DCC The England and Wales Cricket Board (The ECB) GCCC specifically for the purpose of allowing you to purchase discounted tickets.
<b>Legal basis for processing your data</b>	Performing the administration that it is necessary to operate CBCC In all other cases: that it is necessary for our legitimate interests which are to regulate the sport of cricket within the L&DCC and to ensure that the reputation of cricket is preserved and enhanced, and this does not prejudice or harm your rights and freedom
<b>Your right to withdraw consent</b>	Where you have given your consent to any processing of personal data you have the right to withdraw that consent at any time. If you do, it will not affect the lawfulness of any processing for which we had consent prior to your withdrawing it.

<b>How long we will keep your personal data for</b>	We will normally not keep your personal data after you have ceased to be a member. We will keep a truncated portion of your data for identification, archive purposes and for the ensuring your data is not accidentally released.
<b>Your rights in respect of your personal data</b>	You have the right of access to your personal data and, in some cases, to require us to restrict, erase or rectify it or to object to our processing it, and the right of data portability.
