<p><b>Your right to withdraw consent</b></p>	<p>Where you have given your consent to any processing of personal data, you have the right to withdraw that consent at any time. If you do, it will not affect the lawfulness of any processing for which we had consent prior to your withdrawing it.</p>
<p><b>Location of your personal data</b></p>	<p>The Club will keep your personal data within the European Economic Area.</p>
<p><b>How long we will keep your personal data for</b></p>	<p>We will not retain your personal data for longer than is reasonable and necessary for the purposes for which it was collected. We shall retain your personal data for such time as you are registered with <b>Colwyn Bay Cricket Club</b> as a member.</p> <p>After you cease to be a member of Colwyn Bay Cricket Club or play an active part in Colwyn Bay Cricket Club, we keep a truncated version of your data for the Club's archives, details available on request.</p>
